SOME GOOD NEWS

There are many stories of how children seeking sanctuary in the UK have made something remarkable of their lives once settled here.

As a child seeking sanctuary, Gulwali made it across the Mediterranean, through Europe and finally to the UK. He grew up to graduate from University, co-found an organisation supporting young refugees and write a [wonderful book](#).

An asylum seeker who was helped 15 years ago on his journey to Citizenship by an LD4SOS Council member is now a qualified social worker doing valuable work in the community.

In the meantime, a [brilliant question](#) from Roger Roberts in the House of Lords: "My Lords, if we want a cap on net triggers, what about a cap on what is happening in Syria, in Afghanistan and in terms of climate change? These are things we must respond to, if we have any heart at all. Will the Minister go along with this: we must prepare for increased numbers instead of reduced numbers?"

If, as successive Conservative governments have claimed, they wish to help refugees in their home countries, they should not limit the numbers coming to the UK but limit the forces that drive people to migrate.

WAITING TIMES FOR DECISIONS

The Government has published its final immigration statistics for the year 2019, with the number of main applicants waiting for over six months for a decision on their asylum claim increasing for the seventh consecutive quarter. It showed that 56% of the 43,632 asylum cases waiting for a decision were more than six months old. This is the largest backlog recorded in asylum statistics, and it getting worse each year. Lib Dem policy on better decision making, and a radical change in how the Home Office works are in this [document](#).

MOVE ON TIME LIMIT

[This report](#) from Red Cross shows the huge problems caused by the too short period new refugees have (28 days) to find new accommodation and a means of supporting themselves through work, benefits of combination of both.

The cost / benefit analysis even shows that it cost tax payers more to keep present system.

There is an urgent need for the time to be extended to 56 days.

Parliament is going to debate it on March 4th – if time please lobby your MP, and there is a [good briefing here](#) from NACCOM. Our Lib Dem Policy is clear on more time needed for those granted refugee status to move on, [as stated here](#).

DESTITUTE ASYLUM WOMEN

The report, [Will I Ever Be Safe? Asylum-seeking women made destitute in the UK](#), by Women for Refugee Women and their Regional partners explores the experiences of over 100 women from 29 different countries who have been made destitute in the UK after seeking asylum here. They found that:

- Nearly a third of the women they spoke with had experienced sexual violence both in their countries of origin *and again* while destitute in the UK.
- Almost half were street homeless in the UK.
- 95% were hungry, and the same percentage of women were depressed while they were destitute. These women were fleeing violence in order to seek asylum in the UK.
- A third said that they had been raped by state authorities in their countries of origin.
- A quarter of the women had been targeted because of their political activities; 16% are lesbian or bisexual and had been targeted because of their sexuality.

As Liberal Democrats we strongly believe that all who seek sanctuary here should be safe. Destitution should not be happening in our society, and people should be given the right to work. For those unable to work, there must be support for them throughout the time it takes to consider their case and hear any appeals.

DEPORTATION to JAMAICA

This has been much in the headlines, and rightly so.

Christine Jardine, **responding to the news that the Court of Appeal has halted the deportation of many who were set to be sent to Jamaica by the Government, said:**

“What will it take for this Government to learn? Even after the appalling Windrush scandal, Conservative Ministers were brazenly defending their plans to deport people just hours before the court ruled it unlawful. These deportation flights must stop until the Government has published the Windrush Lessons Learned Review in full. No one can trust the Home Office to get these decisions right, and we owe it to the victims of the Windrush Scandal to prevent anything like it from happening again.”

HOW DEPORTATIONS, IF THEY REALLY HAVE TO HAPPEN, SHOULD WORK.

[It is Liberal Democrat policy](#) that deportations should only be done with humanity and follow the National Independent Commission on Enforced Removals (NICER) recommendations on how removals should take place.

THE UNJUST SYSTEM

[This report](#) by Amnesty on an unjust deportation system highlights how bad it has got.

Reports like this show the huge cost to the public purse of today’s deportation system, as well as the huge cost in ruined lives of people and their families.

The [Guardian report](#) highlights the cost of £12,000 per person to remove them. More wasted lives, wasted resources, wasted public money. Just think of the better lives and better uses this time and money could be put to, if indefinite detention and unlawful deportation were ended. Humanity and Justice doesn't have to cost.

When people have served their sentence for any crime committed, they are then punished again, by being sent to a country of which they have little or no recollection. And this double punishment creates injustice to others, children and partners in particular who are suffering the loss of a loved one.

For British citizens, [this barbaric practice ended in 1868](#), when Western Australia, the last British colony receiving convict ships, joined others in refusing to do so any longer.

The Home Office tell us that no British Citizen is deported, but omit to say that it costs over £1,000 for a child from countries such as Jamaica to gain citizenship here. Application fees are meant only to cover administrative costs, not to make money or to be an obstacle to citizenship.

SAFE ROUTES FOR REFUGEES
